Purpose of the meeting

The City of Jacksonville requested that the Florida Housing Coalition facilitate a Housing Strategy Workshop with the goal of aligning the strengths and resources of the public and private sectors in Jacksonville to advance an affordable housing initiative. Topics for deliberation included: public/private partnerships, leveraging private and philanthropic funds with public resources for effective housing programs, community land trusts, and nonprofit capacity building. The results of this workshop and follow-up sessions will help to form a comprehensive strategy for addressing the continuum of housing needs in Jacksonville, from homelessness to homeownership, and to inform the City's 5-year Consolidated Plan which has identified three priority needs to address housing affordability and build inclusive communities: neighborhood revitalization, housing development for homeownership, and affordable housing preservation and development.

Structure of the Workshop

The objective of the workshop was to identify strategies to better deploy public and private resources to improve the housing stock in Jacksonville. To that end, the agenda for the day sought to address the following areas:

- What resources can each organization bring to the effort?
- What would you like to accomplish today?
- What is working well in Jacksonville?
- Identification of goals to address the continuum of housing needs
- Individuals or organizations to include going forward
- Identification of next steps

The Florida Housing Coalition staff made a brief presentation on housing tools and strategies that have been used in Florida and other states including community land trusts, maximizing the use of surplus land, promoting infill development, housing for the missing middle, adaptive reuse, opportunity zones, and permanent supportive housing. The purpose of the presentation was to collect the participants' views on each tool/strategy and to help formulate ideas for the housing tools and strategies to adopt in Jacksonville.

Jacksonville's Successes

Participants were asked to identify the things that are working well in Jacksonville and can help achieve the goal of better public-private partnerships to use resources in a collaborative manner. The following list was generated from the discussion:

- The relationship between the Mayor and the community
- LISC's relationship with the City
- Revolving Loan Fund
- Neighborhood Dept.'s creation and alignment with public, private, and philanthropic sectors
- Jessie Ball DuPont Fund
- Relationship between City, Jacksonville HFA, and FHFC (e.g. local preference)
- Momentum in revitalization of downtown
- Ease of working with Planning Director and Building Official
- Accessibility of City staff and cooperative culture e.g. Duval County's willing to help Jessie Ball DuPont fund when preparing Market Value Analysis (MVA)
- Community of collaborative, high-capacity nonprofit organizations
- LISC relationship with NFL makes affordable housing attractive
- Engaged business community and the second largest Chamber of Commerce in the country
- Diversity and uniqueness of each of the neighborhoods
